FAFSA is the primary means of filing for financial assistance to attend postsecondary school

A F<u>ederal form</u> used to determine: Expected Family Contribution (EFC), Need and Eligibility for:

IRS Data Retrieval Tool



FAFSA "Already Filed" status IRS Data Retrieval Tool

- While completing FOTW, applicant may submit real-time request to IRS for tax data
 » Using the "Already Filed" status
- IRS will authenticate taxpayer's identity
- If match found, IRS sends real-time results to applicant in new window
- Applicant chooses to transfer data to FOTW



IRS Data Retrieval Tool

- FAFSA on the Web will include logic to determine if the student and/or parent(s) is eligible to use the IRS Data Retrieval Tool
- Students and parents who were eligible to use the IRS Data Retrieval Tool but didn't, will receive e-mail reminders encouraging them to return to FAFSA on the Web and use the tool
- <u>If estimated income used</u>, go back once taxes are filed and use IRS Data Retrieval Tool to complete the Verification process

Things to remember:

- Get your PIN: www.pin.ed.gov
- File FAFSA for 2014-15 at FAFSA.GOV
 » Use the IRS Data Retrieval tool after filing taxes
- Do your FAFSA and State Grant app at the same time
- Meet your school's **DEADLINES**
 - » State Grant Deadline for FAFSA, May 1, 2014
 - » School deadlines may be earlier!



What's Next After Filing the FAFSA?

- Student receives Student Aid Report (SAR) via a direct email notification if a valid email address was provided; otherwise snail mail
- Review the SAR for accuracy
- Make any necessary corrections via FAFSA.gov or updating and mailing the paper SAR
- Submit documentation to the school's financial aid office and PA State Grant program if necessary



What's Next After Filing the FAFSA?

- All schools listed on your FAFSA will receive your FAFSA information
- Only after you have been accepted for admission to the school will you receive a Financial Aid Award Letter
- To make an informed decision, you need to compare all of your award letters to understand what it will cost you and your family to attend each school.
